- Member of trial team appointed to the Plaintiffs' Executive Committee in an MDL against **Fresenius Medical Care Holdings**, alleging defective design and failure to warn concerning its dry acid concentrate products, Granuflo and Naturalyte, which were subject to a Class I recall by the FDA. Involvement included discovery and assisting in preparation of corporate witnesses. Helped secure a **\$250 million settlement** agreement.
- Member of the trial team representing plaintiffs in MDL against **Depuy Orthopedics**, a subsidiary of **Johnson & Johnson**, on claims concerning defective design, failure to warn and unfair and deceptive trade practices concerning their ASR hip implant product. Involvement included discovery and assisting in preparation of corporate witness depositions.
- Member of the trial team appointed Co-Lead Counsel in the **AbbVie**MDL, representing plaintiffs against the makers of testosterone replacement therapy products, alleging injuries including myocardial infarction, stroke, pulmonary embolism and deep vein thrombosis. Involvement includes discovery responsibilities and brief writing. Case pending.
