Details regarding the Diversity Fellowship and eligibility requirements are as follows:

## **The Fellowship Program**

Seeger Weiss's 1L Summer Diversity Fellowship (the "Fellowship") provides fellows with exposure to one of the leading Plaintiffs' firms in the nation. Selected 1L students are invited to join Seeger Weiss attorneys for a summer of hands-on training and learning in some of the largest and most important mass tort, class action and social justice cases facing the American justice system. The Fellowship also includes programming with notable legal and non-legal speakers with the goal of fostering mentoring relationships.

The Fellowship — which includes an award of up to \$14,400 plus an additional \$3,000 charitable contribution to a nonprofit organization of the fellow's choice in consultation with the Firm — will be offered to an exceptional rising second-year law student who demonstrates the promise both of becoming an outstanding attorney and of contributing meaningfully to the diversity of Seeger Weiss and the legal community. The Fellow will participate in Seeger Weiss' summer associate program in the year the Fellowship is awarded.

## **Eligibility**

The recipient of the Fellowship must demonstrate academic excellence and leadership abilities, together with personal and professional accomplishments and a commitment to community service. The recipient should also demonstrate a commitment to promoting diversity of experience, inclusion, and accessibility, as well as an ability to offer a diverse perspective to the Firm as a result of wide-ranging life experiences, adaptability, ability to overcome adversity (financial or otherwise), cultural fluency, and resilience in life and in the legal field alike.
